




Quarter over Quarter Stock Indices Price Change

Market Intelligence

7/3/18: Illuminate Education's private equity owner, Insight Venture Partners, combined the company with IO Education, SchoolCity, Alpine Achievement and Key Data Systems. All of these companies specialize in data analytics for the use of educators and administrators.

6/21/18: Vipkid, which provides one-onone video teaching for Chinese children with language teachers based in North America, just raised a U.S. \$500 million series D+ round led by Coatue Management, Tencent Holdings Ltd, Sequoia Capital China and Yanfeng Capital, raising its valuation to \$3 billion.

6/11/18: Sesame Ventures, the venture capital arm of Sesame Workshop, invested an undisclosed amount in Kano, a company that develops do-it-yourself computer and coding kits for children of all ages.

6/7/18: Lincoln Learning Solutions, an online provider of pre-K through 12 educational curriculum content, is seeking further acquisitions and partnerships both in the U.S. and internationally, as well as looking at a few potential strategic joint venture partners.

5/1/18: Primrose Schools, a Roark Capital backed operator of franchised early childhood education centers, announced it will consider both small and large acquisitions. Primrose would be interested in acquiring regional chains based in the U.S. with five or more schools.

4/25/18: CampusLogic, a student financial aid services platform, announced \$55 million in funding led by JMI Equity, which will fund additional strategic acquisitions to expand the company's SaaS solutions.
