Lincoln Perspective

Lincoln International is pleased to release its Q2 2022 Food & Beverage Quarterly Review. The second quarter remained busy across the industry, but at a more normalized level compared to the record pace of 2021. Q2 2022 is when many are expecting (in hindsight) "peak" inflation due to extended shutdowns and supply chain problems in Asia and commodity related spikes from the war in Ukraine.

Q2 marked a return to good, old fashioned in-person activity for the Lincoln team. As the COVID-19 Omicron variant surge and broader pandemic concerns subsided, Lincoln bankers, but also the industry more broadly, returned to inperson management meetings, pitches and marketing meetings as well as offices full of interns this summer.

The Lincoln food and beverage team had an active Q2. With a strong backlog of engaged clients and an active pitch pipeline, we expect continued strength in the food and beverage deal market through the balance of 2022 and beyond. In fact, as questions persist around the broader economy, many investors are treating the food and beverage sector as a "safe haven," potentially fueling slight premiums on valuations for companies in the sector.



Food & Beverage Index


Commodity Prices Index¹



Observations:

- Key commodity gains accelerated rapidly through most of Q2.
- While commodities remain at elevated levels, forward curves indicate further declines as the Federal Reserve continues tightening and many parts of the world deal with softening demand in areas of the economy.
- Corn and soybean prices remain near highs due to rising input costs, drought in South America and greatly reduced output from Ukraine expected for the foreseeable future.
- Wheat prices are up nearly 44% year-over-year (YOY) through June as Ukraine harvests an estimated 30% this summer and key exporters Canada, Russia and the U.S. had poor 2021 harvests.
- Oil prices traded sharply up in early Q2 but have begun to recede. Prices are expected to remain at elevated levels due to underinvestment in the industry.

Observations:


- While still very elevated, protein prices finally started to moderate as Q2 came to a close.
- Wholesale beef prices increased 9.5% YOY in Q2, but this was the slowest pace of growth since August 2021 and may signal declining demand.
- Pork prices have continued to moderate as China's pork output rose to 13.78 million tons in Q2, its highest since 2015. While prices are expected to remain elevated on a historical basis, they will likely continue to moderate.
- Poultry prices have continued to climb, with the price per pound for boneless skinless chick breast up 22% YTD through Q2 and 36% YOY.


Restaurant and Grocery Store Sales Indices¹



Observations:

- Restaurant sales have continued to accelerate through the late spring. Consumers, despite inflation, continue to spend on experiences and services.
- The biggest headwind for restaurants remains the availability of labor and cost of all inputs, which will continue to weigh on margins.
- Grocery store sales have continued to grow, but are primarily being driven by inflation. Food-at-home inflation in June reached 12.2%, three times the rate in June 2021.
- Skyrocketing food inflation is causing a shift in how consumers spend at the store, with many trading to private label brands and cheaper sources of protein.

Consumer Food Price Index Inflation¹



Observations:

- As discussed throughout, inflation continues to be the "concern du jour" for both consumers and the broader business community.
- June 2022 food-at-home prices were up 12.2% vs. 7.7% away-from-home.
- All food increased 10.4% YOY through June, the largest increase since February 1981.




Food & Beverage Industry Stock Performance Index¹




Median Food & Beverage Transaction Multiples¹

Notable M&A Transactions

Mondelez has agreed to acquire of Clif Bar

Enterprise value: \$2.9 billion

Revenue multiple: Approximately 3.0x

EBITDA multiple: n/a

Date: June 2022

- Mondelez announced an agreement to acquire Clif Bar, a manufacturer of energy bars, for \$2.9 billion with additional earnout considerations.
- Mondelez acquisition of Clif Bar expands Mondelez's global snack bar business to over \$1 billion in revenue, including their previous acquisition of Perfect Bar in the U.S. and Grenade in the UK
- The acquisition will help build on Mondelez's prioritization of fast-growing snacking





Bolthouse Farms has agreed to acquire of Evolution Fresh From Starbucks

Enterprise value: n/a Revenue multiple: n/a EBITDA multiple: n/a

Date: May 2022

- Bolthouse Farms announced an agreement to acquire Evolution Fresh, a producer of organic cold-pressed juice products, from Starbucks for an undisclosed sum.
- The acquisition will expand Bolthouse's portfolio of organic juices and smoothies, generate material synergies and allow Starbucks to focus on their core portfolio.
- Additionally, Bolthouse will expand Evolution Fresh's distribution in the grocery channel while maintain its presence at Starbucks store locations.







Pete's has been sold to Local Bounti

Enterprise value: \$122.5 million

Date: April 2022

- Indoor farming company Local Bounti acquired rival Hollandia Produce Group, which grows and sells leafy greens under the name of Pete's, for \$122.5 million.
- The acquisition helps Local Bounti quickly expand its indoor farming knowledge and retail footprint.
- All of Pete's 130 employees will join Local Bounti and its management team will remain in place to lead what will become a subsidiary of the firm.
- Lincoln International represented Pete's / Hollandia Produce Group on the transaction.
